Course Overview

This course provides the student with the training, skills and knowledge required to apply for the Australian Communications Media Authority (ACMA) Open Cabling Registration. Both theoretical and practical training are included in this course. The College's modern 'state of the art' cabling training facilities allow for skills to be practiced in a simulated workplace environment.

Course Content

The course consists of four nationally recognised modules:

- ✓ NTC 004 Regulatory Framework 2
- ✓ NTC 014 Basic Telephony
- ✓ NTC 017 Switching Systems Overview
- ✓ NTC 111 Telecommunication Cabling Installations

Course Requirements

Students applying for Open Cabling Registration must satisfy one of the following course pre-requisites:

- ✓ Current Unrestricted Electricians Licence or
- ✓ 600 hours experience, to be proven in writing. Please see below for clarification.

Evidence of either of the above will be required upon your registration with the Cabler Registry

ACMA Open Criterion for Cabling Experience

As set by the Australian Communications Association

Where Cablers require short-term experience to progress to the Open Cabler Registration, the following criteria can now be used to clarify the definition of "short-term" cabling experience:

The experience proposed by the candidate should meet the first three criteria in all cases, and at least four of the other criteria as listed.

- ✓ Experience comprises of at least 600 hours of work on cabling tasks within the last 2 years
- ✓ Cabling experience was supervised by a Registered Cabler
- ✓ Cabling work undertaken is covered by one or more Australian Technical Standards

ACMA Open Criterion for Cabling Experience *continued*

- ✓ Installation of distributor systems involving capacity of 20 lines
- ✓ Installation of earthing protection
- ✓ Creation and interpretation of cable plans
- ✓ Assistance in Cable testing and fault rectification
- ✓ Preparation of TCA reports for customers
- ✓ Interaction with customers

Evidence of experience must be provided and signed off by a registered Cabler who has supervised the candidate. Please state the criteria met, and sign off giving the current registration number.

Course Duration

5 Days (40 hours) - Full Time

Skills Recognition

Our skills recognition process benefits students, who have achieved prior training skills or knowledge and applies to Skills Recognition, Recognition of Prior Learning (RPL), Credit Transfer, Advanced Study or Exemption.

If you believe you are entitled to any of the abovementioned we encourage you to fill out the Application Form for Skills Recognition, which is available from our administration team. Your application will be assessed on an individual basis.

Course Fees

Subsidised course fees may be available to persons currently working in the building and construction industry or unemployed persons who have worked in that trade in the previous 6 months.

The fee subsidy does not apply to persons working in the security and mining industries and Government employees.

To be eligible for subsidised course fees students must sign the 'Fee Subsidy Declaration' on the course registration form and Work History Form.
