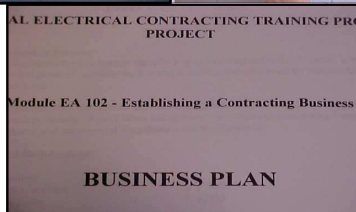
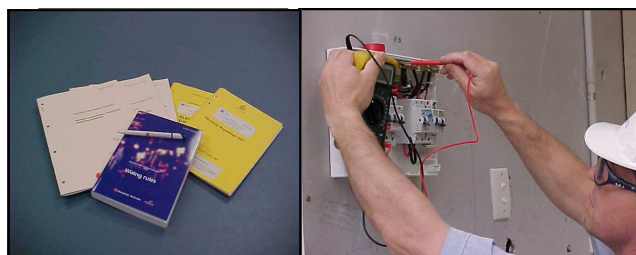

### Course Overview

Where the required modules are completed this course provides qualified electrical mechanics and/or electrical fitter/mechanics with the training, skills and knowledge required to apply for the Electrical Contractors or Electrical Contractors Nominees / In-house Licence. The course is structured to include both theoretical and practical training. The College's training facilities allow for skills to be practiced in a simulated workplace environment.

This course is designed to build upon electrical trade studies and includes broadening the knowledge and skills in electrical installation practices, statutory requirements, inspection of electrical installation work and where an Electrical Contractors Licence is sought, job management and business operations.

In the case of a business, other than an Electrical Contractor, that needs to undertake electrical work on site, a person other than an electrician may hold the business aspect of the licence. In this situation the electrical work may be completed, under that licence, by an electrician employed by the company and nominated by the employer as the Nominees / In-house Licence holder.

### Course Content

The **Electrical Contractors Licence** course consists of four mandatory competency based modules.

The **Electrical Contractors Nominees / In-house Licence** course consists of two mandatory competency based modules, EA103A and WAE100.

The **Electrical Contractors Business Licence** course consists of mandatory competency two modules, EA102 & EA103B.

All modules are nationally recognised.

### EA103A - Operation (Electrical) Legislative Requirements (10 hours)

#### Module Learning Outcomes

- Investigate and identify State legislation relevant to the electrical operations of an organisation in the provision of electrical services
- Analyse the intent and implications of the identified legislation and apply it to the procedures and processes of an electrical contracting company

### WAE100 - Electrical Requirements (30 hours)

#### Module Learning Outcomes

- Apply Australian electrical standards and relevant State publications to a variety of situations associated with small to large electrical installations
- Describe and apply specific statutory technical and occupational requirements associated with the functions and duties of electrical personnel
- Analyse and apply the correct sequence of procedures for inspection, testing and commissioning of electrical installations
- Determine and observe appropriate safety and supervisory procedures in an electrical environment

### EA102 - Establishing a Contracting Business (40 hours)

#### Module Learning Outcomes

- Evaluate those factors that influence the performances and structure of a small contracting business
- Establish a marketing plan for a small contracting business
- Evaluate the labour costs and profit margins associated with a small contracting operation

### EA103B - General Legislative Requirements (20 hours)

#### Module Learning Outcomes

- Investigate and identify State and Federal legislation as it applies to:
  - \* the structure of an electrical contracting business; and
  - \* workplace relations and human resources; and
  - \* the marketplace
- Analyse and describe the intent and implications of the identified State and Federal Legislation
- Establish an electrical operational plan and policies to give effect to the procedures, processes and legislative obligations of an electrical contracting business

### Course Requirements

Entry to module WAE100 will require the student to hold a current Unrestricted Electricians Licence. **Evidence of this must be presented in order to confirm your enrolment on this course.**

For general entry to the other modules a background in the electrical industry is preferable, although not mandatory.

Application for licence issue should be made to Energy Safety (phone 08 9422 5282) within twelve months of completing the mandatory course modules.
