Course Overview

The qualification is designed to provide applicants with the skills and knowledge to access an apprenticeship in the Electrotechnology Industry. In addition to essential knowledge and practical skill development the qualification offers applicants with the opportunity of work experience in the electrical trade. Applicants also have the opportunity to develop a high level of individual and team communication skills.

Course Content

The qualification includes: 6 Core; 1 Stream Core; and 5 Supervised Skills Practice/Work Placement Units of Competency plus a selection of Elective Units of Competency relevant to the Electrical Apprenticeship.

Course Dates

The course is dependant upon available Government funding. Please contact the College administration team for commencement dates.

Course Duration

Duration of the course will be for 596 hours. 200 hours will be allocated to work experience for the development of employability skills achieved through work placement.

Entry Requirements

To be considered for entry to this course applicants should have completed year 10 studies attaining minimum 'C' grade levels to stage 4 or better in Math, English and Science.

In addition, all applicants are required to undertake a literacy and numeracy test administered by the College.

Applicants meeting entry requirements will be invited to attend an interview at the College. Suitability for course enrolment will be assessed at this meeting.

Skills Recognition

Our skills recognition process benefits applicants who have achieved prior skills or knowledge and applies to Skills Recognition, Recognition of Prior Learning (RPL), Credit Transfer, Advanced Study and/or Exemption.

If you believe you are entitled to any of the abovementioned we encourage you to fill out an Application Form for Skills Recognition which is available from our administration team. Applications will be assessed on an individual basis.

Fees / Austudy

The College of Electrical Training attracts the same financial support from the Government as any other registered training provider ensuring there is no cost disadvantage to applicants.

Fee reductions are available for applicants who are able to provide approved concession on enrolment.

Applicants enrolled in full-time courses are eligible to apply for means-tested Department of Training and Workforce Development, Employment and Workplace Relations allowances. Applications for allowances are to be made through Centrelink. We will supply supporting documentation on request.

- ✓ Persons and dependants of persons in receipt of AUSTUDY or ABSTUDY
- ✓ Persons and dependants of persons in receipt of the Youth Allowance or
- ✓ Persons who are inmates of a custodial institution
