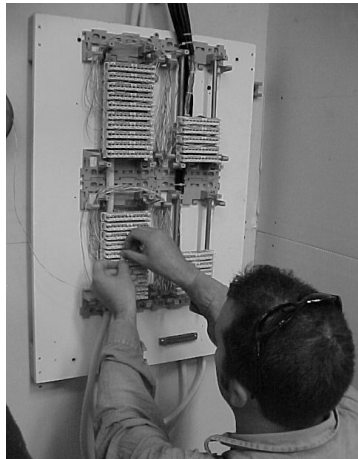

Course Overview

This course is an extension to the ACMA Base Cabling Licence and provides the student with the training, skills and knowledge required to correctly install and terminate Category 5/6 cabling.

Course Aim

To provide the student with the training, skills and knowledge to correctly install Category 5/6 cabling to the transmission and topology requirements of the current AS/NZS 3080 to meet client communication needs in a commercial environment.

This module relates to ITCTC009A – Place, secure and terminate Category 5/6 cable for certification of the Telecommunication Cabling Competency Standards.

Module Learning Outcomes

- State the design principles and installation requirements for Category 5/6 Structured Cabling to current AS/NZS 3080
- Select cable and cabling hardware which is Category 5/6 compliant with AS3080-95
- State the cabling hardware and cabling characteristics which determine Category 5/6 performance and impact on the cabling environment on these characteristics
- Install Category 5/6 cabling and hardware in accordance with the current AS/NZS 3080, AS 3084 and the suppliers recommended practices
- Recognise and rectify Category 5/6 cabling installation non-compliance with current AS/NZS 3080, AS 3084 and explain the impact of such non-compliance on transmission performance.
- Identify typical computer and LAN cabling systems and topologies and explain how Category 5/6 cabling supports these systems and topologies

Course Requirements

Students applying for Open Cabling Registration must satisfy the following course pre-requisites:

- Certificate III in Electrical (Electrician / Electrical Mechanic) or equivalent certificate or
- 'A' grade Electrical Licence or
- 6 months aggregated verified experience in cabling (supported by a letter from the employer)

Cabler Registration

Skills Recognition
