Course Overview

This course is designed for Western Power accredited electrical contractors and authorised electrical workers undertaking "Energising the Installation" tasks.

Learning Outcomes

- Identify the requirements of the Contractor Connect Scheme
- Identify the legislative requirements applicable to the Contractor Connect Scheme
- Perform installation testing and verification
- Perform pillar connections
- Perform meter connections, testing and sealing
- Identify the Main Earth Neutral (MEN) connection requirements
- Identify the administrative requirements including auditing, refresher training and notices

Course Requirements

Students need to hold a current Unrestricted Electricians Licence.

Persons wishing to undertake this course should contact the Western Power Inspection Services branch (**phone 08 9359 7552**) prior to enrolment to determine eligibility for entry. Further, attending students must complete their Western Power Service Connect course at CET or have previously obtained their "H" accreditation through Power Training Services. The Service Connect card or "H" accreditation certificate with a copy of the approval letter from Western Power must be attached to the course registration form and payment before confirmation can be given.

The CET safety policy requires all course participants to wear enclosed shoes, long sleeves and long pants whilst on CET premises.

Course Duration

Full time - 1 day (8 hours)

Certification and Assessment

Upon successful course completion students will be provided with a Certificate of Completion by the CET and an 'Authorised to Connect' card will be issued to participants by Western Power.

Theoretical and practical assessment will consist of the following:

- A written test on the theoretical aspects of the learning outcomes
- Final tests for an energised installation including fault finding
- Energise the installation

Course Delivery

This course focuses on the practical aspect of testing and connecting service connections. Various training aids and activities are included in the course (eg live connections) to enable participants to directly apply the knowledge gained in the workplace.

Students are required to obtain the following material for reference during this course:

- AS/NZS 3000: 2007 Wiring Rules (available from the CET)
